The approximate extent and character of the work is generally described as follows:

Airport Parkway Extension Project:

This project will include the extension of Airport Parkway to the southeast to tie directly to the airport terminal parking lot. The project will include grading drainage, paving, hardscape elements, fencing, grassing, and erosion control. All excavated soil/rock material will be placed onsite to the east of the existing terminal as depicted on the plans.
